



READMISSION INSTRUCTIONS FOR UNDERGRADUATE STUDENTS RETURNING TO RISD AFTER A LEAVE OF ABSENCE

Purpose: Readmission to RISD after a voluntary or involuntary leave requires completion of the “Application for Readmission” form which is available from the Registrar or online at www.risd.edu/registrar.

Note: Students who take a voluntary medical leave must apply for readmission through the medical leave readmission process. Contact the Office of Student Affairs at: studaff@risd.edu or 401.454.6600 for Medical Readmission Instructions.

General Information:

- The student must contact their department head at the time of applying for readmission, or before, in order to seek advice and ensure that there is space. The department head’s authorization for the student to return is a mandatory part of the application process. If you are seeking to change majors upon return, you must contact the department head of the major you wish to enter.
- If you have been away from RISD for four years or more, you will be required to satisfy the graduation requirements in effect at the time of your readmission.
- **International Students:** The Office of International Student Services cannot process immigration paperwork until the readmission has been fully approved. Applications should be submitted earlier than deadlines below to allow for the additional processing time required.

Application Filing Deadlines:

Fall semester entry: Return form by **April 1** (undergraduates)
Wintersession and Spring entry: Return form by **October 1**

Instructions:

1. Complete the Application for Readmission Form available at www.risd.edu/registrar

Note: Students on a medical leave of absence must contact the Office of Student Affairs at 401-454-6600 to apply for readmission. Do not use the general readmission application.

2. Resolve any outstanding balances on your student account. Contact the Student Accounts Office at 401.454.6445 or studentaccts@risd.edu Your application for readmission cannot be processed if there is an outstanding balance.
3. Have you completed all of your Freshman Foundation studios? If not, you must contact *both* Foundation Studies, (401.454.6176 or foundation@risd.edu) and your intended major department for readmission approval.
4. Students requesting readmission as a returning major must contact the major department for approval. Readmission decisions are subject to availability of seats in your designated program.
5. If your leave of absence specified certain conditions that had to be met prior to your return (e.g. academic conditions), then you must submit evidence of having met those conditions and attach required documentation when submitting the application.
6. Return the application to the Registrar’s Office after obtaining appropriate department approval.
